## Construction Project Manager Job Title Summary

<b>Job Description</b>	A Construction Project Manager is responsible for managing and overseeing the construction project from start to finish. This includes planning, budgeting, coordinating and supervising construction projects, ensuring that they are completed on time, within budget, and to the specified quality. They also work with architects, engineers, and other construction professionals, liaise with clients, and ensure compliance with safety and building regulations.
