Despite the setback, we were still able to complete the project within the agreed timeline.

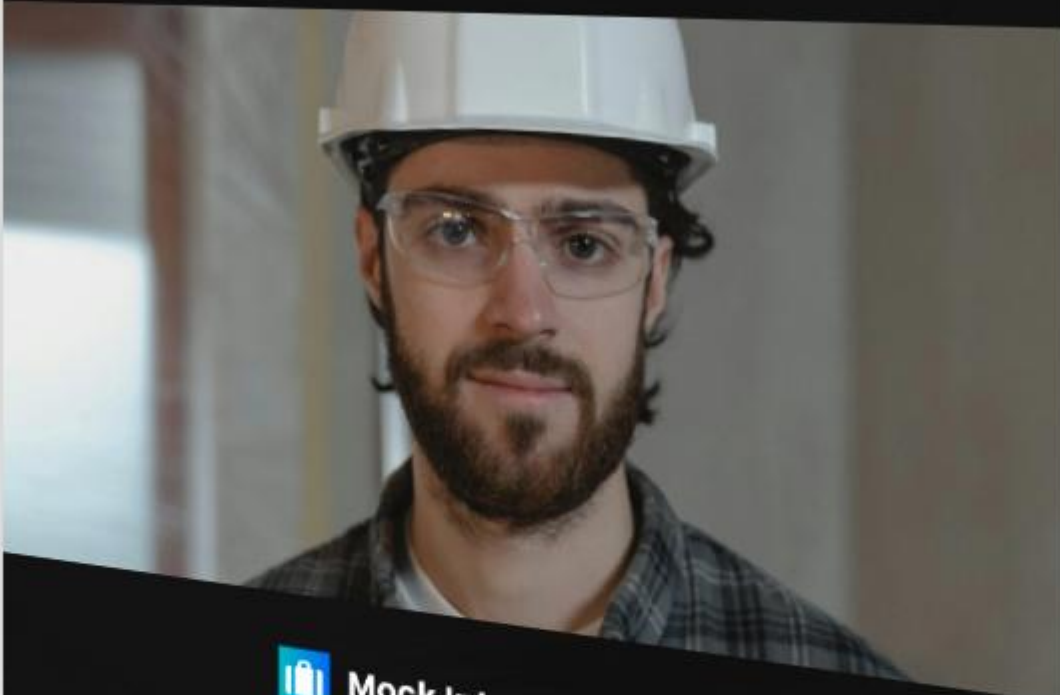

### **Sample Answer**

In one of my previous projects, we had a situation where a key stakeholder was unhappy with the progress of the project. They felt that we were falling behind schedule and not communicating effectively. I promptly arranged a meeting with them to discuss their concerns. I presented them with a detailed plan showing what had been completed, what was in progress, and the timeline for the remaining tasks. I also implemented a weekly project update to keep them informed. This approach reassured the stakeholder and improved our relationship. By the end of the project, they were satisfied with both the process and the final result.

### Sample Answer

Yes, in my previous role as a Construction Superintendent, I had to incorporate Building Information Modelling (BIM) software into our practices. The decision was made due to the software's capabilities in enhancing our efficiency in coordinating and communicating project details. The transition was challenging, but I organized training sessions for the team and liaised closely with the software provider for support. Over time, we became proficient in using the software and it improved our overall productivity and reduced errors in our projects.
