Police Interview Questions

Describe a situation where you had to make a decision under pressure. How did you handle it?

How to Answer

How to Answer

Sample Answer

If the situation allows, I would confront the officer in question and ask about the behavior I observed. However, I understand the importance of following official procedures and would make sure to use the appropriate channels to report such behavior.

Can you tell us about a time when you had to deal with a particularly difficult individual? How did you handle the situation?

How to Answer

The interviewer is looking for evidence of your problem-solving skills, communication abilities and patience. The best approach to answering this question is to provide a specific example and explain what the situation was, what actions you took, and what the result was. Remember to focus on the steps you took to de-escalate the situation and not on the negative aspects of the person's behavior.

Sample Answer

In my previous job as a security officer, I dealt with a regular visitor who was often aggressive and disruptive. One day, he was particularly upset and was causing a disturbance in the lobby. I approached him calmly and respectfully, acknowledging his frustration and explaining the need to maintain a peaceful environment. I listened to his concerns and promised to pass them on to management. He calmed down and agreed to leave peacefully. This situation taught me the importance of patience, empathy, and effective communication in dealing with difficult individuals.

What steps would you take to de-escalate a tense situation?

How to Answer

What is your understanding of the ‘use of force’ policy in policing, and how does it guide your actions in high-stress situations?

How to Answer

In your answer, demonstrate your understanding of the ‘use of force’ policy and its importance in maintaining law and order. Highlight how it influences your decision-making process, especially in stressful situations. Explain how you balance the need to protect public safety with respect for individual rights. You can also include any training you have had that helps you apply the policy effectively.

Sample Answer

The ‘use of force’ policy is integral in policing. It guides officers on the appropriate level of force to use, depending on the situation at hand. The primary goal is always to maintain public safety, but it’s equally important to ensure that the force used is proportionate and necessary. In high-stress situations, I rely on my training and experience to apply the policy. I took the wallet to my supervisor and reported it as a lost item. A few days later, a man came to the security office looking for his lost wallet. He was relieved to find all his money still in it. I believe that maintaining my integrity in this



situation was paramount, even though no one was watching me.

What steps would you take if you were first on the scene of a serious road accident?

How to Answer

The interviewer wants to evaluate your ability to handle emergency situations, your knowledge of first-aid procedures, your ability to prioritize tasks, and your understanding of police protocol. Start by explaining the first thing you would do, then outline your subsequent steps, making sure to demonstrate your knowledge of police procedures, public safety, and first-aid. Show your ability to remain calm under pressure, and to think logically and quickly.

Sample Answer

First, I would ensure my own safety by parking my patrol car in a safe location, then I would activate my emergency lights to warn other road users. I would immediately report the accident to the dispatch center, providing them with all the necessary details, and request additional resources if needed. I would then approach the scene cautiously, assess the situation and check for any immediate dangers like fire or hazardous materials. My next priority would be to provide first aid to the injured, starting with the most seriously injured. Once backup arrives, I would move to managing traffic or crowd control, preserving the scene for investigation, and gathering witness statements.

Police Job Title Summary



Job Description A police officer is responsible for enforcing laws and maintaining peace within a community. Their duties include responding to emergency situations, patrolling assigned areas, conducting traffic stops, issuing citations, arresting individuals, conducting investigations, writing detailed reports and providing testimony in court.

Skills Critical thinking, Physical stamina, Communication skills, Problem-solving skills, Leadership, Empathy, Integrity, Knowledge of laws

Industry Law enforcement, Public Safety

Experience Level Entry level to advanced, depending on the specific position and department

Education Requirements High school diploma or equivalent, though some departments may require a college degree. Must also complete police academy training.

Work Environment Police work can be physically demanding, stressful, and dangerous. Officers regularly work at crime and accident scenes and encounter suffering and the threat of violence. Although a career in law enforcement may take a toll on officers' private lives, many officers find it rewarding to help members of their communities.

Salary Range The median annual wage for police and detectives was \$65,170 in May 2019, according to the Bureau of Labor Statistics. The lowest 10 percent earned less than \$37,710, and the highest 10 percent earned more than \$109,620.

Career Path Police officers usually become eligible for promotion after a probationary period. Promotions to corporal, sergeant, lieutenant, and captain usually are made according to a candidate's position on a promotion list, as determined by scores on a written examination and on-the-job performance.
