My quick decision making helped prevent a potential crime.

<b>Job Description</b>	<p>A Security Officer is responsible for ensuring the safety and protection of a company's employees, visitors, and associated property. Security officers are tasked with patrolling and monitoring activities on company premises to discourage theft and violence. They may also be responsible for the use of surveillance equipment, the enforcement of company policies, and the preparation of reports on regular basis.</p>
